In accordance with article 4 and 5 of the temporary Statute of the International Public College of Business in Mitrovica, the Regulation of IBCM College no. 987, dated: 10/10/2024 for the awarding of scholarships for IBCM students, and the Law on Higher Education of the Republic of Kosovo 04L/37, the IBCM College announces:

Extension of the call for Awarding Scholarships

The IBCM College announces two types of scholarships for the academic year 2024/25:

- I. Merit-based scholarships;
- II. "Dardana Petershoni" scholarship for students with lower socio-economic conditions.

I. Merit based scholarships

1. All students of the IBCM College at the Bachelor and Master level, who meet the following criteria, are eligible to apply for a merit-based scholarship:
 - 1.1. Be regular students at IBCM College;
 - 1.2. Be in the second year of studies or higher;
 - 1.3. Have not a repeated year of studies;
 - 1.4. Have passed all the exams of the previous years by the exam term of September 2024;
 - 1.5. Have at least 70% attendance in lectures in each of both semesters;
 - 1.6. Have an average grade, at least:
 - 1.6.1. 10.0 (according to the IBCM grading system) for students pursuing studies in the Bachelor's program in Public Administration and Welfare, in the Bachelor's in International Sales and Marketing, and in the Master's program in International Management and Leadership;

- 1.6.2. 7.5 (according to the IBCM grading system) for students pursuing their studies in the Bachelor's program in applied IT, and in the Bachelor's in Environmental and Agricultural Management;
2. To apply for a merit scholarship, students must submit the following documents:
 - 2.1. The application form (downloaded from the IBCM website or physically obtained from the student service), completed and signed;
 - 2.2. Grade certificate (obtained from the student service);
 - 2.3. A letter from the respective Faculty about the student's regular status;
 - 2.4. Confirmation sheet from the respective Faculty on the attendance of lectures in the two semesters of the academic year 2023/24
 - 2.5. The declaration under oath (downloaded from the IBCM website or physically obtained from student services), completed and signed;

II. "Dardana Petershoni" scholarship for students with lower socio-economic conditions

1. Scholarships for students with lower socio-economic conditions are allocated to students of Bachelor's and Master's studies at IBCM College, who come from families with lower socio-economic conditions.
2. The right to apply for this scholarship is available to all students of IBCM College at the Bachelor's and Master's level, who meet the conditions and criteria listed below.
3. The criteria for awarding these scholarships are as follows:
 - 3.1. To come from families with lower socio-economic conditions;
 - 3.2. Be regular students at IBCM College;
 - 3.3. Have registered the relevant academic year for which the scholarship is awarded;
 - 3.4. Have at least 70% lecture attendance for the academic year for which the scholarship is awarded (for 1st year students are applicable the lecture attendance during the month of October);
 - 3.5. Have an average grade of at least seven (7) according to the IBCM grading system (not applicable for 1st semester students).
4. To apply for this scholarship, students must submit the following documents:
 - 4.1. Application form (downloaded from the IBCM website or physically obtained from the student service), completed and signed;
 - 4.2. Grade certificate (obtained from the student service);
 - 4.3. Proof of the socio-economic status of the family, in any of the cases listed below:
 - 4.3.1. families that are on social assistance (evidence obtained from center for social work);

4.3.2. families that have a self-supporting parent with a monthly income at / below the minimum wage determined by the Government of Kosovo (work contract, or tax administration evidence, or any other relevant evidence);

4.3.3. families that do not have any members employed at work regular (evidence from pension system, or tax administration evidence, or any other relevant evidence).

4.4. Certification from the Faculty about the student's regular status;

4.5. Confirmation letter from the Faculty on the continuity of lectures in the two semesters of the academic year for which the scholarship is announced.

4.6. Declaration under oath (downloaded from the IBCM website or physically obtained from student services), completed and signed;

III. Application deadline and submission of documents

3. The application period is from 29/10/2024 to 08/11/2024.
4. The submission of documents is made to the student service at the IBCM College.
5. Please make sure you submit all required documents as required per criteria of this call.

IV. Announcement of results and complains

1. The announcement of the results from applications for this call will be done until 13th November 2024.
2. Students applying for the scholarship schemes have the right file an appeal, against the decision of the IBCM College for awarding scholarships, to the IBCM Appeals Committee, within 5 days from the announcement of the scholarship decision.
